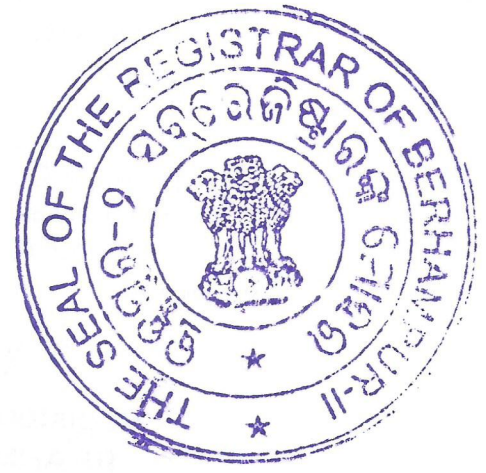

6. To accept donations, grants and other offerings and to deal with the name for the purpose of the Trust.
7. To charge tuition fees and other fees to recoup expenditure incurred in upkeep and maintenance of the institution established and to established under this deed.
8. To train and to equip the pupils so as to be self-supporting in any honourable and decent way of life so as to develop in to good citizens.
9. To develop disciplinary conduct and a habit to observe the rule of the law and self-restraints.
10. To bring out, encourage and develop the inventive and research facilities to the students and teachers and to provide an opportunity for research work in arts, science, industry and other fields.
11. To contribute towards human resources development in the country.
12. To establish, maintain or grant aid to home for the aged, orphanages or other orphans, widows and aged persons.
13. To sell dispose of, alienate or otherwise deal with any property comprising the trust fund.
14. To let out, demise any immovable property comprised in the trust fund for much period at such rent and on such terms and conditions as the trustees in their discretion may think fit.
15. To make, vary, alter or modify schemes, rules and regulation for carrying out the objects of the trust and for the management of the affairs thereof and/or running any institution furtherance of the objects of the trust and otherwise for giving effect in the objects of the trust.
16. To apply to the Government, Publics holders, Urban, Local Municipal, District and other bodies, Corporations etc. for and accept grant of money of aid, donation gifts, subscription and other assistance with a view to promoting the objects of the corporations, persons scheme and other work and matters within the frame work of the objects of the

Trust and to confirm to any proper condition upon which such grants other payments may be made.

17. To take over, acquire manage, control, organize or maintain or to assist in establishing, promoting, managing organizing or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and promote or carry on the with affiliation or amalgamation of such other Trust with this Trust.
18. The funds of the Trust shall be kept in any bank or banks and shall be operated by the two permanent trustees Jointly.
19. The Trustees may out of the corpus of the Trust expend such money or part thereof for laying out erecting and furnishing any building, research institute or for incurring expenditure as may be unanimously resolved by the Trustees.
20. The permanent Trustees may appoint FIVE more Trustees of their choice to function as Co-trustees and their tenure of office shall be not more than two year from the date of appointment unless they are re-nominated for further period by the permanent trustees by their mutual consent.
21. The temporary co-managing Trustee will exercise their duties as co-trustees subject to the control and supervision of the permanent Trustees and in case of any prior notice.
22. That either of the Two permanent Trustees shall represent the institution for all purposes including to sue and to be sued.
23. That the permanent Trustees shall have the power to nominate their successors to be permanent Trustee, failing which Two of their heirs shall become permanent. Trustee, the said procedure of line of succession shall be adopted in future also.

24. The permanent Trustees may appoint other staff members required for the institution and remove them whenever it is considered necessary in the interest of the institution.
25. The account year of the trust shall be the financial ending 31<sup>st</sup> March every year.
26. The permanent Trustees shall have the power to add, alter amend any of the clauses mentioned herein for the advantage/ benefit of the trust and society.
27. The permanent Trustees/ Directors shall have the power to borrow money from the Banks/financial institutions/individuals as is necessary for fulfillment of the objects of the Trust and to mortgage/hypothecate/pledge or provide security any immovable or movable property of the Trust as security for such borrowings. The permanent trustees and co trustees, regarding such borrowing, can execute necessary documents agreements.
28. To open fund establish, promote set-up run, maintain, assist finance support and/or maintain and/or run establishments or institutions for the advancements of education Science, Arts, Commerce, Humanities, Computer Science, Engineering, Management, Medicine Health and other useful subjects in all their manifestations.
29. To publish or help in publishing books, pamphlets, periodicals and Newspapers of the media of mass communications for the spread and advancements of education culture and science.
30. To give, provide and/or render food, medicines, to organize health camps and other help and/or assistance in any shape or form to the deserving and needy persons.
31. To give provide and/or render monetary and/or other help assistance for the relief of persons and animal affected by natured and other calamities such as flood, fire, famine, cyclone, earth-quake, storm,

32. To establish, maintain or grand aid for the establishment or maintenance of wells, tube wells, tanks, water-reservoirs and trees and contractions of and repairs to paths; roads bridges etc. for the use of public the assistance of Central Government and State Government or International Bodies.
  33. To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or running hospitals, boarding houses, libraries, reading rooms, Gymnasium and other training and vocational institutions.
  34. To open, fund, promote, setup, run, maintain, assist, finance, support advance and encourage primary, secondary and higher education including technically and medical education also physical training, training of handicrafts, fine arts and other useful arts, crafts among the public including the establishment and maintenance of Shilpa-Sikhyalayas, Kala Kendras and other welfare centers for them.
  35. To grant, pay or give scholarship, stipends, prizes rewards, allowance and other financial assistance or help in cash or kind to students with a view to help them in continuing their studies in schools, colleges, Educational institutions, Technical institutions, Art Schools, Colleges, Educational Institutions, Technical Institutions, Art Schools, institutions teaching commercial and other arts including teaching of cultural arts or other training research or educational works in India or abroad.

37. The Trustees may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineer, Surveyors, Clerks or other employees for the purpose of management and supervisions of the Trust keeping the accounts record and for other purposes of the Trust.
  38. The trustees may establish its office at such place or places may change such places from time to time as they may think fit.
  39. The Trustees may joint Co-operated and amalgamates the trust created by these persons or nay portion thereof with any trust or Institution having allied and or similar Object upon such terms as they may in their discretion think fit.
  40. The numbers of Trustees shall be not less than two or more than seven.
  41. Two Trustees at a meeting shall form a quorum, for any meeting of the Trustees.
  42. All meetings of the Trusts shall be held at such places at such time as the Chairman/Vice-Chairman of the Trust shall decide from time to time.
  43. No persons being –
    - a. An undercharges insolvent or
    - b. Convicted of an offence involving moral turpitude or
    - c. Of unsound mind or
    - d. A minor, shall be eligible to be a trustee.
  44. The power to appoint new or additional trustees but so as not to exceed the maximum number and to fill vacancies in the office of the Trustees shall vest in the permanent trustees.

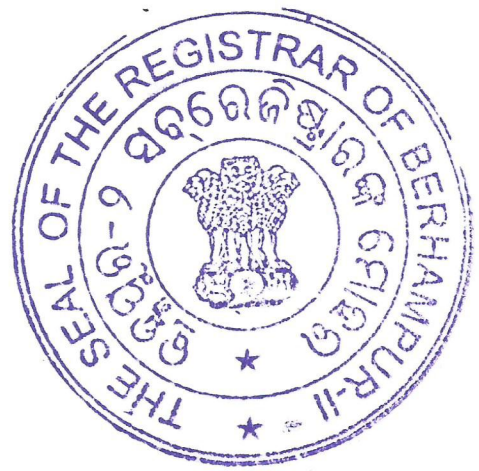
**Investment Clause:** The funds of the trust shall be invested in the modes specified under the provisions of section 13(1) (c) and section 11 (5) of the I.T. Act 1961 as amended from time to time.

**Accounts Clause:** There shall be maintained all accounts of the Trust regularly. The accounts shall be duly audited by a qualified Chartered Accountant. Every Year the accounts shall be closed by 31<sup>st</sup> March.

**Amendment Clause:** No amendment to the Trust Deed/Memorandum of Association/By-Laws/Rules and Regulations shall be made which may prove to be repugnant to the provisions of Sections 2(15), Section 11, Section 12, Section 13 and Section 80G of the I.T. Act, 1961 as amended from time to time. Further, no amendment shall be carried out without the prior approval of the Commissioner of Income Tax

**Dissolution Clause:** In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Managing Committee/Governing Body but the same shall be transferred to another charitable Trust whose

objects are similar to those of this Trust and which enjoys recognition u/s. 80G of the IT Act, 1961 as amended from time to time.

- Irrevocability Clause: The trust formed shall be irrevocable.
- Beneficiary Clause: The benefits of the Trust shall be open to all irrespective of caste, creed or religion.
- Utilization Clause: The funds and income of the Trust shall be solely utilized for achievement of the objects of the Trust and no payments shall be made to the members by way of profit, interest/dividends etc.
- Area of operation: The area of operation of the Trust is limited to India/Place etc
- Aim of Society: To provided skilled, education/training to enable younger generation to develop self-confidence and the skills to compete and succeed in the National and International field for the benefit of the students belonging to whatever community irrespective of Caste, Creed or Religion whole of India in the state of Odisha and also in other part of the country.

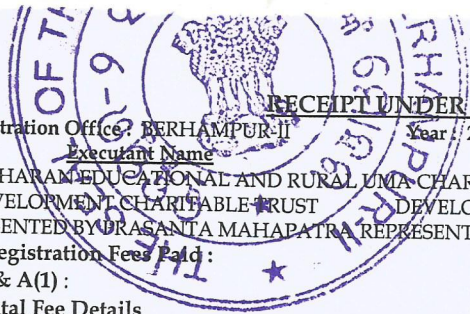




